As disclosed in the Announcement, the Company issued the Waiver Letter (which was acknowledged and agreed by the Noteholders), pursuant to which the Noteholders conditionally agreed to waive certain Terms and Conditions in relation to the redemption of the Convertible Notes prior to the Maturity Date to allow the Company to redeem the Dragons Notes from Dragons in full amount of HK\$280,000,000 on the Redemption Date. The Dragons Notes is redeemed in full by the Company on 31 July 2019.
